FURTHER OPERATING UPDATE OF THE VIETNAM NHON TRACH
PRODUCTION FACILITY IN VIEW OF THE RECENT
DEVELOPMENT OF COVID-19 IN VIETNAM**

This announcement is published by Vietnam Manufacturing and Export Processing (Holdings) Limited (the “**Company**” and its subsidiaries, collectively the “**Group**”) on a voluntary basis.

References are made to the announcements of the Company dated 21 July 2021, 2 August 2021, 17 August 2021, 1 September 2021, 16 September 2021 and 30 September 2021 (the “**Announcements**”) in relation to the latest operating update of the production facility of the Group in Nhon Trach Industrial Zone II of Dong Nai Province in Vietnam (the “**Vietnam Nhon Trach Production Facility**”) in view of the recent development of the outbreak of the coronavirus disease COVID-19 (the “**COVID-19**”) in Vietnam.

As stated in the Announcements, the Vietnam Nhon Trach Production Facility was suspended for a period of 79 days from 22 July 2021 to 8 October 2021. The suspension of operation was however extended due to more stringent COVID-19 containment measures subsequently imposed by the local authority in that region. The Vietnam Nhon Trach Production Facility is subject to a further suspension period of 7 days until 15 October 2021. The Company will continuously monitor the situation and will make further announcements as and when appropriate.

Shareholders and potential investors of the Company are advised to exercise caution when dealing in the securities of the Company.
