POLL RESULTS OF ANNUAL GENERAL MEETING HELD ON 13 MAY 2010

The Board hereby announces that at the AGM held on 13 May 2010, all of the proposed ordinary resolutions as set out in the AGM Notice were duly passed by the Shareholders by way of poll.

Reference is made to the notice (the “**AGM Notice**”) of the annual general meeting (“**AGM**”) of Vietnam Manufacturing and Export Processing (Holdings) Limited (the “**Company**”) dated 12 April 2010 and the circular (the “**Circular**”) of the Company dated 12 April 2010. Unless otherwise defined, terms used herein shall have the same meaning as in the Circular.

At the AGM held on 13 May 2010, all of the proposed ordinary resolutions as set out in the AGM Notice were passed by the Shareholders by way of poll. The Company’s branch share registrar in Hong Kong, Computershare Hong Kong Investor Services Limited, was appointed as the scrutineer for the vote-taking at the AGM. There was no share of the Company entitling the holder to attend and vote only against the ordinary resolutions proposed at the AGM. No Shareholder was required to abstain from voting on the ordinary resolutions at the AGM. No Shareholder has indicated in the Circular that it/he/she intended to vote against the ordinary resolutions at the AGM or to abstain from voting.
